# Approval of Bond Ordinance and Tax anticipation Ordinance

For the record, please note that the 2022 Extended tax levy amount is \$2,466,745 with a 4.99% increase which comes out to be \$123,089 bringing the 2023 proposed tax levy to \$2,589,834.
- c. Approval of treasurer's report for July 2023, August 2023, and September 2023.
- **d.** Approval of bills for July, August, September 2023, and October 2023 for Calumet Memorial Park District.
- **e.** Approval of payroll for July, August, September, and October of 2023 for the Calumet Memorial Park District.
- **f.** Acceptance and approval of the repair and refurbishment of the Sandridge Community & Fitness Center gym floor to be performed by Kiefer USA after competitive bidding through Sourcewell Cooperative Purchasing for the estimated amount of \$87,440.
- **g.** Acceptance and approval of the proposal and estimate to paint Sandridge Community and Fitness Center gym to be performed by Prism Commercial Painting and Decorating, LLC for an estimated amount of \$29,390.
- **h.** Approve a change in the job title of the Superintendent of Parks and Maintenance to Director of Parks and Maintenance.
- i. Approve sending of staff and commissioners to the annual IAPD/IPRA conference on January 25 through 27, 2024 in Chicago, IL.
